Requirements

Public Notice: Notice of such hearing shall be published in a newspaper of general readership in the locality at least (1) time (15) days prior to the hearing date. Fee for this publication is applicant's responsibility. Legal proof of publication must be given to the agent for the board prior to the hearing date.

- The applicant will file a completed "affidavit of mailing" prepared by a licensed abstractor, with the agent of the board (10) days prior to the hearing date. Failure to file the affidavit of mailing within the allotted time or if the mailing list is found to be incorrect, may be grounds to deny the application.

- Mailings of "notice to property owners" will be mailed by a licensed abstractor to all owners of record, at their last known address, of property within (300) feet of affected tract.

- Plot plans, photographs and other factual information and evidence which will assist the board in reaching an informed decision should be attached or brought to the hearing.

Note: If a transcript is required, it is the responsibility of the applicant.

Meetings are held 3rd Tuesday of the month in courtroom #4 on the 1st floor of the Wagoner County Courthouse.

Frequently Asked Questions (FAQ)

Time for filing?

Each application shall be filed with the agent of the Board of Adjustment (Director of Planning Commission) (30) days prior to the date of the public hearing at which it is to be considered, unless there are extenuating circumstances.

Filing fee?

The filing fee is \$20.00, payable upon presentation of completed application.
