5. Mayor's Report

Mayor Jones told the Council that the Streetscape Project was progressing and areas that have been filled in with dirt will be bricked when the sidewalks are complete. The contractor filled the area with dirt for safety reasons until after the Bluegrass Festival is over. We have electrical conduit and irrigation systems to go in before the brick work can be done. The Stormwater Project is progressing as well but crews are working around things as they arise due to the fact that we are digging up infrastructure that has been in place over a hundred years. The sidewalk project that runs from Polk Avenue to meet up with the Streetscape Project is starting soon. The contractor began mobilizing equipment and supplies today. The mill and fill of Cherokee is the last project and they hope to do that late October or early November. There will be a ribbon cutting when all of the projects are completed. The RAISE Grant documents are online if the public would like to view them. Paperwork for the project will begin in the next 45 days and there will be public meetings held prior to construction which should begin in FY 2024/2025. The Cherokee Nation opened a career services center on Casaver during the month. The Bluegrass Chili Festival is September 9 & 10, 2022. Kelly O'Deneal with the hospital told the Council that the drug takeback event at the hospital resulted in 37 pounds of discarded medications being collected which are turned into a company that converts them into energy.

Employee of the month was awarded to Thomas Applegate, Street Department Foreman, by Mayor Jones and HR Director, Lori Hall.

13. Departmental Reports

The hospital report was given by the Jimmy Leopard. Mr. Leopard advised that they had a Covid outbreak in the mental health unit and had to relocate patients to be isolated in other parts of the hospital which caused that unit to go on a divert status. This resulted in lower revenues for the month of July. Louise Dodson has retired from the hospital and Mr. Leopard introduced Reava Burton who is the Chief Nursing Officer at the hospital. Ms. Burton spoke to the Council and gave a brief review of her experience.

Dwayne advised that this had been a busy month with ongoing projects being done by the City employees as well as contractors working in the downtown area. The portion of the stormwater project at Casaver and Cherokee was quite labor intensive due to unforeseen things discovered during the digging process. A natural gas line was marked wrong and was hit by our workers which resulted in a delay while ONG came in and made repairs. The pool has closed for the season and this was a phenomenal year at that facility. The Parks and Recreation employees stepped up with running the pool and made it a success.

The Police Dept. was asked about the new cars they had in the budget for the last two years. We were just informed that they would be building one of the ten vehicles ordered and the rest of the order had been cancelled. We will order 2023 models and the numbers will change based on the incentives available. We have now decided to get some SUV's and some trucks instead of all trucks.
