5. Mayor's Report

City of Wagoner employee of the month was Sean Goodwin, EMT for Wagoner EMS. Mr. Goodwin was presented his award by Mayor Self and EMS Director, Jim Roberts.

Mayor Self gave his report to the Council and advised that the Trunk-R-Treat was a huge success and the City of Wagoner Library won the best decorated trunk contest. Mayor Self thanked the library staff as well as Thomas Applegate, Street Dept. Supervisor, for their participation in the event. Josh Bogle donated the Gazebo that was located in the small park on S. Main to the City of Wagoner. Wagoner Wrecker assisted with moving the gazebo and CA Land Clearing placed it in Lincoln Park. Appreciation was expressed to all who volunteered their time and equipment to make this happen. The Park committee received a \$5,000 grant from LREC and the Police Department received a \$50,000 grant from the Cherokee Nation. The Fire Department received a \$10,000 Forestry Grant. Mayor Self thanked Chief Haley, Chief Grooms and Jim Roberts for working on obtaining these funds.

Deputy Police Chief Tony Ponds addressed the Council and Mayor in regard to an accident his wife had while working at Wagoner Public Schools. He commended the Wagoner Hospital and Wagoner EMS for the great care she received from all of them. He expressed his appreciation to everyone involved in his wife's care. He also advised that the Police Department was hosting a Self Defense Class for women at the Civic Center on Saturday, December 11, 2023 from noon until 3:00 p.m.

Kristen Mallett announced the "Scan For a Grand" was being held again this year. We have forty businesses participating in the program. This program is held to encourage citizens to shop at our local businesses.

Gayla Wright announced that Mike Fox had donated \$20,000 to help with the development of parks in Wagoner.

Mayor Self announced that October 17, 2023 had been proclaimed "Wagoner Band Day" in Wagoner to give recognition to the band for their success at competitions this year and all of their hard work.

Employee Christmas lunch will be held December 8, 2023 at the Civic Center at noon.

Jimmy Leopard told the Council their report was in the packet and he was available to answer any questions if needed. Mr. Leopard thanked Tony Ponds for his kind words in regard to his wife's treatment at the hospital. He stated they had seen a rise in COVID cases but they were less severe and they had very few patients hospitalized with COVID.

Tony Lowe gave the WEDA Report and updated projects they were working on. DMI has 56 employees and is expanding and looking to hire 20 more. North American Heat Exchangers is ahead of schedule and they have units ready to ship out but are just waiting on trucks to

transport them. The Small Business Grants were given to Miranda's, Patie on the Hill and Wagoner Music. The Board received an offer on the property on McQuarrie but it was rejected. They are working on trying to get a Dollar General Fresh Market or store for that location. The awnings have been ordered for the Harris Building and the shadow boxes should be installed by Christmas. Work is continuing on the plans for the area known as "BOB" in downtown. They are trying to get some funds from Wagoner County to assist with this project. The Music Store has opened on McQuarrie as well.

Dwayne was not at the meeting but the City of Wagoner report was in Council packets.
