5. Mayor's Report

City of Wagoner employee of the month was Corey Nevitt, School Resource Officer. Officer Nevitt was presented his award by Mayor Self and Chief Haley.

Mayor Self gave his report at this time and advised that we had our new sound system installed in the Council room but it was only partially working tonight. We are having trouble connecting to the YouTube channel but will call the company tomorrow and try and get the issue resolved. The Firefighters Challenge will be held on S. Main on Saturday, September 9, 2023 and will begin at 10:00 a.m. Mayor Self had an idea to raise funds for more Christmas lights for Wagoner and we will be offering the chance for people to sponsor one of the big snowflakes that are hung on the poles each year for \$50.00 each. The round snowflake will be put on the City website for bids and the highest bidder will be able to select the location of that snowflake for the season. The hanging pots for the downtown light poles will start being installed next week. There was a family in town that had an issue with their sewer line and the fix was going to be expensive. Buddy Rose with Prestige Plumbing worked with the family to get the repairs made for them and did not charge the family. It is people like that make this town amazing. Mayor Self began the Athlete of the Week again and it will be awarded each week during the school year.

Discussion and possible action – To approve or not approve Ordinance No. 969 – An Ordinance changing the Zoning Classification of a tract of land in Sections 3 and 10 of Township 17 North, Range 18 East of the Indian Base and Meridian, City of Wagoner, Wagoner County, State of Oklahoma, according to the US Government survey thereof; which includes Block 23, 24, 43 and part of Block 68, City of Wagoner thereof from Single Family High Density (RS-1) to Heavy Industrial (IH); amending the Zoning Map of the City of Wagoner, Oklahoma; repealing all ordinances in conflict therewith; and declaring an emergency

Mayor Self stated that Rusty Kite who is part owner of North American Heat Exchangers would like to address the Council on this rezoning. North American Heat Exchangers requested the zoning change to the property. They are going to clean up the property and it will be utilized as storage for their facility. There will be no truck traffic on Frost Lane and all truck traffic will continue to use the industrial road on NW 11th to access the facility. They will install a privacy fence between the area and the residential areas. The zoning change will allow all of the property owned by the company to have the same zoning classification.

Scott Yandell spoke to the Council in regard to this matter. Mr. Yandell lives at 509 Honeysuckle Lane and advised that he was not against the company but that he had concerns about the rezoning changing the whole campus of the area. Mr. Yandell questioned why they would not just change it to a commercial zoning and why the rush to rezone the property.

Lloyd Stanley spoke to the Council about this matter. Mr. Stanley owns property adjoining the proposed rezoning area. He expressed concerns about there being a buffer between the houses and the industrial property. He was concerned about truck traffic at night and the additional noise it would create. Mr. Kite answered questions about the property and advised that their shipping hours were 7:00 a.m. to 3:30 p.m. and all loads going out of the facility were permitted loads and would never be allowed to be shipped at night.

going through the Dept. of Commerce for assistance on business recruitment. Bids have been requested for the demolition of the Reynolds property on McQuarrie and that should be torn down soon. The deal with Crown Castle has been closed and they are moving forward on solutions for the Harris Building and plans for the area known as "BOB" on S. Main.

Dwayne gave his report to the Council and advised that City staff had been busy with construction projects as usual. National Night Out was held in August and Chief Haley wanted to thank all of the departments that participated along with the Police Department in this event. EMS has received their Tahoe and we are in the process of getting quotes from the banks for the remount of the EMS boxes on new units. We should be getting an official letter from ODOT in a couple weeks regarding the paving of Cherokee Street. It will most likely have to be re-bid and ODOT will be sending in crews to do some patching to get us through until it can be completely redone. Bids for the City of Wagoner asphalt for this year will be opened on September 7 and we will have a recommendation for the Council on that project after that date. We have three Street Dept. employees who have completed the CDL licensing process and are now licensed. We are working on getting more employees through this course and licensed.
