INSTRUCTIONS

Public Notice

- Notice of such hearing shall be published in a newspaper of general readership in the locality at least one (1) time ten (10) days prior to the hearing date. Fee for this publication is applicant's responsibility. Legal proof of publication must be given to the City of Wagoner prior to the hearing date.
- The applicant must file a completed "affidavit of mailing" prepared by a licensed abstractor, with City of Wagoner ten (10) days prior to the hearing date. Failure to file the affidavit of mailing within the allotted time or if the mailing list is found to be incorrect, may be grounds to deny the application.
- Mailings of "notice to property owners" must be mailed by a licensed abstractor to all owners of record, at their last known address, of property within three hundred feet (300') of the affected tract.
- Plot plans, photographs, and other factual information and evidence which will assist the board in reaching an informed decision should be attached or brought to the hearing.

Note: If a transcript is required, it is the responsibility of the applicant.

Meetings are held on the second Wednesday of the month in the council chambers at the City of Wagoner City Hall, 231 Church Street Wagoner, OK.

Frequently Asked Questions

Time of Filing

Each applicant shall be filed with the City of Wagoner thirty (30) days prior to the date of the public hearing at which it is to be considered, unless there are extenuating circumstances.

Filing Fee

The filing fee is \$200 for variances and special exceptions; \$100 for appeals.
