# 5. Mayor's Report

The employee of the month for February was Officer T.J. Ponds, Wagoner Police Department. Officer Ponds was presented his award by Mayor Jones and Dwayne Elam.

Mayor Jones gave his report at this time. He stated that Bill Smith had submitted the hazard mitigation plan so that we could receive monies to help with a pump at the dike. A trip hazard was identified on the Streetscape Project and was taken care of last week. The paving project is to begin as soon as weather permits and the contractor is available to work in Wagoner. The RAISE Grant was approved for ODOT to be the Project Manager. Monies for that project will be run through ODOT and not the City of Wagoner. We will probably have to conduct a special meeting to approve the funding agreement and get those documents submitted and the next phase will be selecting a designer. The Coal Creek lift station is in operation now. North American Air Exchangers has purchased the old LaBarge facility and will be renovating those buildings and expanding their company to Wagoner.

At this time the Council deviated from the agenda and moved to Item #24.
