# 3. Chairman's Report

Chairman Self gave his report to the Board at this time. Chairman Self stated that our community had suffered the loss of Tony Lowe. We are grateful for his years of service to the community. We will have big shoes to fill on the WEDA Board and the City of Wagoner extends prayers to the family.

Chairman Self presented City and WPWA employees of the month. Officer Michael Barnett was City employee of the month. Carl Hill, water distribution operator, was WPWA employee of the month.

Chairman Self thanked St. James Episcopal Church for opening up their church as shelter during the cold spell. He thanked Councilor Rhoden and Kelly Odeneal for heading up this project. Chairman Self will have an E-Doc sign for the Cherokee Nation Grant on Tuesday. The swings are up at Lincoln Park and mulch and border are being ordered. Lincoln Park is being utilized. The MLK Parade was moved due to the weather. The parade was held and it was still cold but the parade was held.

4. Discussion and possible action – To purchase employee health insurance

Gary Broom and Amber Martin with Premiere presented information on the insurance items on the agenda. They went over the benefit packages being offered. Options were presented on the health insurance for employees. Two plans from Community Care and one from Blue Cross Blue Shield. The second option from Community Care also included gap insurance to help with covering the deductible and out-of-pocket costs. Discussion was held as to these options and the associated costs with each one. Staff recommended going with Option C from Community Care and the gap insurance.

We have had remote medical service with Teladoc for a few years but have been experiencing some issues with that service. A new remote medical service offered through Revive Health is being recommended this year. The cost will be twenty-five cents more per employee but it will offer more benefits. Employees will have access to Mental Health remote health as well as a number of medications that will be at no charge. Staff recommended going with Revive Health for this service.
