# 5. Mayor's Report

Mayor Jones wished everyone in attendance a Happy New Year. The OWRB loan for the stormwater project closed in December. The Stormwater committee will be meeting on Tuesday, January 4, 2022 and a public open house/information session will be held at the Civic Center on January 18, 2022 from 4:00 p.m. until 7:00 p.m. The Christmas parade and music shows were held in December. We will discuss during budget planning if we want to continue with the shows.

6. Discussion and possible action – To enter into an Engineering Services Contract for the 2021 CDBG Project Coal Creek Lift Station Replacement – Bidding and Construction Phase Engineering Services with Holloway, Updike and Bellen, Inc.

Mayor Jones told the Council that we had received two quotes for this service and had used the scoring sheet provided by the Federal Government to review the quotes. Holloway, Updike and Bellen, Inc. had all of the required documents in their quote. The committee scored both proposals and Holloway had the higher score. Dwayne told the Council that the Department of Commerce requires us to go through this process and the HUB was more apt to meet the needs of the City of Wagoner on this project.

9. Discussion – Hiring of one additional full-time firefighter

Councilor Wright had asked last month that we get an update on this item. Deputy Fire Chief Jimmy Cagle addressed the Council. He advised that the plan was to add an additional firefighter in the next budget year. He stated that they were handling the current work load and would like to continue to operate the way they were at present until next budget year.

Councilor Schilling inquired if they planned to be ready to hire a firefighter in July, 2022. Mr. Cagle advised that they were moving forward with the process to try and be ready by that time.

### 10. Unscheduled public appearances

There were no unscheduled public appearances.

### 11. Departmental Reports

Jimmy Leopard gave the hospital report and advised that they were seeing large numbers of Covid cases at the hospital. They administered 300 Covid tests during the month of December and have had 208 admissions since the beginning of the pandemic. He advised that the hospital continues to grow and introduced Dr. Kristofor Kalvig to the Council. Dr. Kalvig is a podiatrist specializing in foot/ankle treatment and general foot care.

Dwayne advised the Council that the laws regarding Commercial Drivers Licenses have changed and we are struggling to get testing times for employees. It is becoming a challenge to retain employees who have these licenses and we will have to address this issue going forward.

Park & Recreation Supervisor, Kenneth Peters, presented information to the Council on the bridge replacement that was budgeted for the bridge on the walking trail. He presented a budget for the project as well as a drawing which was done by our engineering firm. The bridge will be manufactured locally by Boyd Welding and it meets ADA standards. It will be a steel structure with wood flooring.

Councilor Samson inquired if the bridge would be widened and if it would affect stormwater in the park.

Mr. Peters advised the bridge could not be widened but we would clean out the debris under the bridge to improve the water flow. The bridge will not affect the stormwater in the park.
