5. Mayor's Report

Mayor Jones told the Council that the Veteran's Day event was held at the Court House and was attended by the EMS, Fire and Police Departments. The Stormwater Committee has been meeting and are hoping to hold a public forum on January 18, 2022 at the Civic Center where citizens can obtain information and make comments. Travis Meyer was present for the tree lighting and that event was well attended. Shop Small Saturday was November 27 and there was a 5k run and pop-up shops downtown on that date. The Christmas parade is scheduled for Thursday, December 2, 2021 and there are around 127 entries to date. Mayor Jones gave a report to the Council in regard to the Bluegrass Festival held in September. Mayor Jones addressed a petition signed by three citizens and a letter he received in regard to the petition. The Council was provided with copies of the petition and letter. He advised that the petition asked for changes to the City Charter. The City of Wagoner is not a Charter city so the items in the petition cannot be addressed as presented. Rhonda has been working on getting the minutes on the website for several months and will continue to do so. The Christmas concert series at the Civic Center has been well attended.

Mayor Jones presented 25-year plaques and pins to Ken Hicks, City Attorney and Chris Jones, 911 coordinator/dispatcher at this time. These plaques are provided by the Oklahoma Municipal League and recognize 25 years of service to the City of Wagoner.

6. Discussion and possible action – To approve donation of sick leave to employee, Bo Henson

Thomas Applegate told the Council that we had awarded the contract on 9/3/2021 and work was set to begin on September 30, 2021. The contractor was advised of and agreed to these dates during the pre-construction conference. No work has been done as of this date. The contractor did deliver some equipment to Wagoner which had the name of another contractor on it. Several attempts were made to contact the contractor and calls were not returned and emails went unanswered. A meeting was held with Ken Hicks to discuss using the next lowest bidder but we are past the time that a bid can be awarded to another contractor so the entire project will have to be re-bid. Steve Powell with Infrastructure Solutions gave information to the Council on when we could bid this project. He advised we could make a few changes to the bid packet and bid in January and hopefully begin the project around March 15, 2022. Discussion was held as to this item.

Chief Haley told the Council the GeoSafe Software was a CAD system and GPS tracking system that allows law enforcement officers to run tags and drivers license checks in their cars. This system can also help with officer safety by providing locations of officers as well as fire and EMS units that may require assistance. The program is priced by the number of licenses and the minimum number of license if fifty. All of the entities listed got together to make the software more cost effective for all of the agencies.

Doug Moore told the Council that this revision was to address the ongoing issue of personal property being kept in hangars. An inspection was recently completed of a few hangars that were cited in the prior inspection for having personal property stored in them. The Airport Board recommended at their last meeting to use the FAA Standards in the lease. Doug advised that he has sent this revision to the Corps for their approval. Invoicing will be done this month to hangar owners.

Thanks was given to all City and WPWA employees that assisted in putting up all of the Christmas displays this year. That program continues to grow each year and we actually had to turn down some people this year due to time constraints on getting displays delivered. The Fire Department had their new truck at the meeting and Mr. Elam encouraged the Council to look at it after the meeting.

Councilor Schilling had questions about the pop-up shops held and the positioning of the booths. Mayor Jones advised that all businesses were notified ahead of time and the event went through the permit process.
