5. Mayor's Report

Mayor Jones gave his report to the Council at this time. He advised that the Stormwater Committee and the Park Committee needed to set up meetings during this month. The Stormwater Committee members are Councilors Schilling, Sampson and Wagoner. The Park Committee members are Councilors Sampson, Wright and Butler. We will try to have a public

hearing on the Stormwater Projects on December 13, 2021 at the Civic Center. Mayor Jones advised that all three of our ODOT projects were approved and contracts were awarded.

6. Discussion and possible action – To enter into a contract for Solid Waste Management Service with Pryor Waste & Recycling, LLC

Councilor Wright asked if commercial accounts could choose who they want for trash service. Councilor Wagoner advised that after the date of the contract that they could not choose service provider. Jim Hinds contract has ended and this is a new contract with a new provider. Discussion was held as to this item. Ken Hicks advised the Council that this was a sole service provider for residential and commercial trash service in the city of Wagoner. He advised that C & C Sanitation can keep their current customers but cannot get any new accounts.

Second Observation of Construction – Gibson Grove – FPM-2018-002

Gentlemen:

In response to the request for a second observation of construction of the Gibson Grove – Phase 1 Development for Floodplain Development Permit FPM-2018-002, we reviewed the site on November 1, 2021 at approximately 11 AM and compared the site review with the specific items included in our "punch-list" from the first observation of construction performed on October 4, 2021.

All of the items have been addressed. The following are construction issues that still need to be addressed, but are **not applicable** to the approval of the Final Plat at tonight's Council Meeting.

- 1. The rip-rap that was placed on the west "hammerhead" needs to be pulled back against the new concrete paving once it has cured.
- 2. The grading of the lots needs to be completed in accordance with the approved Phase 1 grading plan as lots are being developed for house pads. There are several lots that were observed to have "ponding" water from the recent rains and there are lots that appear to be sloped in the wrong direction and will cause potential house flooding issues if the grading is not revised.

These issues can be addressed during further development of the Phase 1 Project and should be resolved prior to issuance of any Certificates of Occupancy.

We recommend that the final plat be approved.
